

## **ROCK 108's Decode Disturbed**

These contest rules are specific to the Rock 108 Decode Disturbed Promotion (the "Contest") conducted by NRG Media, LLC d/b/a KFMW (the "Company" or the "Station"). Ticket winners can win additional prizes by attending a station event on Thursday, October 3rd at 6 PM at LOCATION

Who Can Enter This Contest:

Contestants must be 21 years or older to enter the contest. There will be no possibility of tie-breakers for this contest.

How to enter:

There are 2 ways to win:

**On-Air:** listen every weekday from 6 AM to 10AM, between Monday, September 2 and Friday, September, 27 to be caller 8. A total of 20 pairs of tickets (40 tickets total) will be given away on the air.

**In Person:** Join C.C. at Aces and Eights Saloon, 62 16th Avenue South West Cedar Rapids, Iowa 52404, on Thursday, October 3<sup>rd</sup> from 6 PM to 7 PM to have a chance to win one of eleven (11) pairs of tickets. Listeners can enter a drawing by completing a registration form with their name, address, email address, telephone number and date of birth and dropping it in the contest entry box before 7 PM.

At 7:05 PM, C.C. will draw eleven (11) names to win the final eleven (11) pairs (22 total tickets) to Disturbed and In This Moment in at the U.S. Cellular Center in Cedar Rapids on Wednesday, October 9, 2019. The final eleven (11) winners, will also be qualified to enter to win a signed Disturbed guitar and/or meet and greets with Disturbed.

Ticket winners can join Rock 108 at Aces and Eights Saloon, 62 16th Avenue South West

Cedar Rapids, Iowa 52404, on Thursday, October 3rd from 7 PM to 8 PM, to win additional prizes, including a pair of meet and greets with Disturbed and/or an autographed Disturbed guitar.

Rock 108 will hand out one (1) envelope to each of the 31 qualifiers in attendance. Each envelope will contain a six (6) digit code. Qualifiers will be instructed to not open their envelope until 7:45 PM. At that time, C.C. and Promotions Manager Connor Kenney will reveal one (1) number at a time from the winning code. Three (3) codes will match the first five (5) numbers in the code, each of those winners will win one (1) of Rock 108's meet and greets. One (1) of those three (3) will match all six (6) digits of the winning code to **also** win the signed guitar.

#### Prizes:
